This is an Enforceable Undertaking given under Section 9.5 of the Environmental Planning and Assessment Act 1979 (NSW) by Mawland Quarantine Station Pty Limited ACN107088157

Person(s) giving the Undertaking

This Undertaking is given to NSW Planning by Mawland Quarantine Station Pty Limited ACN107088157 (MQS) for the purposes of section 9.5 of the Environmental Planning and Assessment Act 1979 (NSW))

Background

The North Head Quarantine Station Conservation and Adaptive Re-Use Proposal was approved 23 December 2003 subject to conditions (08_0041, modified 25 May 2018; approval). The coproponents are National Parks and Wildlife Service (NPWS) and MQS. The approval is a transitional Part 3A approval. Continuation of enforcement arrangements are provided in the Environmental Planning and Assessment (Savings, Transitional and Other Provisions) Regulation 2017, Schedule 2, Clause 22.

On 11 May 2022 MQS transferred the Lease (LPI Dealing No. AC928975B) to North Head Sydney Pty Limited (**Purchaser**) with the approval of NPWS. MQS operated the Quarantine station site until March 2022, which is when the lease was purchased by a third party. MQS does not currently operate the Quarantine station site.

An independent audit of the site was completed in February 2022. The findings of the independent audit report is annexure A to this enforceable undertaking.

Acknowledgement

In response to NSW Planning's investigation, MQS acknowledges that its conduct contravened the Environmental Planning and Assessment Act 1979 (NSW) and offers this Undertaking to NSW Planning.

MQS acknowledges that it may have caused environmental harm through the non-compliances outlined in the independent audit report.

Commencement of this Undertaking

This Undertaking comes into effect when:

- (a) this Undertaking is executed by MQS and
- (b) this Undertaking so executed is accepted by the Planning Secretary of NSW Planning or delegate. (the Commencement Date).

Undertaking

MQS undertakes, on acceptance of this Undertaking, to:

- a) contribute a total sum of \$20,000 towards two nominated North Head enrichment programmes on or before 15 February 2023:
 - These nominated programmes are the North Head Sanctuary (\$10,000) and the Australian Wildlife Conservancy (\$10,000); and
 - MQS will provide NSW Planning with a receipt from the programmes on or before 1 March 2023.
- b) prepare a consolidated report and provide it to NSW Planning (draft by March 31, 2023, Final by 31 May 2023). This report will be in a form reasonably acceptable to NSW Planning. The report is intended to:
 - address the use and care of the Site under MQS tenure in relation to environmental monitoring;
 - o confirm the position of environmental monitoring as at the date of purchase;
 - o include attaching relevant and available documentation held by MQS; and
 - be valued at approximately \$20,000.

MQS also notes that it has separately been in negotiations with the purchaser of the lease for the Quarantine Station site. In order to ensure the best environmental outcomes for North Head, MQS is paying an amount of \$125,000 to the Purchaser. MQS understands this amount will be used to obtain best practice site-specific environmental outcomes through contributing to new site-wide environmental plans. The payment to the Purchaser does not form part of this Undertaking but is included as an additional outcome of the audit report and NSW Planning's investigation.
