
#### **Program Objectives & Benefits**

#### **Objectives**

- To support the recovery of the NSW economy during and after the COVID-19 pandemic.
- Reprioritise DPIE's resources and bring forward 'shovel ready' projects for assessment.
- Activate the economy via the pipeline of planning projects and create investment certainty and confidence in the planning system.
- Cut red tape and fast-track the planning processes to keep people in jobs and the construction industry moving throughout COVID-19 crisis.

#### **Benefits**

- Create opportunities for more than 30,000 construction jobs in the next six months.
- Fast-track planning proposals & assessment of Major
   Projects, Rezoning and DAs.
- Support councils and planning panels to fast-track regionally significant DAs.
- Introduce a 'one stop shop' for industry to progress projects that may be 'stuck in the system'.



- All projects to be prioritised need to be able to be determined within 4 weeks of being announced in a tranche.
- The first four tranches will include only projects that are capable of having a determination made within the 16 week program.
- Projects not included in the first four tranches will be further reviewed and prioritised for fast-tracking.

#### **Selection and Approval Process**

#### **Approval Criteria**

- Approve Program Objectives and Prioritisation Criteria.
- Review of program criteria by DPIE Executive Panel.
- Criteria reviewed by ICAC and Probity Advisor.
- Prioritisation criteria endorsed by Inter-Dept Precincts Committee.
- Approval of Prioritisation Criteria by Secretary of DPIE.



- Ensure advice available on nominations.
- Nominations received.

· Nominations recorded.



#### Gate 3 – Approve

- Review of proposed projects by DPIE Executive Panel.
- Probity Advisor advise on compliance.
- Recommendations for review by Precinct-Steering Committee.
- Decision of prioritised project list by DPIE Secretary.

#### Gate 2 – Assess

- Short list and identify opportunities for fast tracking DPIE assessment team.
- Objective assessment of assumptions relating to project's compliance with prioritisation criteria.
- Validating & documenting assumptions and decisions relating to qualification against assessment criteria.

#### Gate 4 – Announce


- Secretary advises Minister of approved projects
- Announce through Media Release, Website and Notification to impacted parties.

#### Identification of Projects for Potential Inclusion in Tranche



Assessment team process

Identify projects that meet criteria and refer to assessment teams for verification Assessment teams to confirm assessment timeframes economic and public benefit, jobs and dwellings (if applicable). Assessment teams to contact proponents where applicable and confirm construction readiness within 3 months or 6 months after determination date. Assessment teams to document their evidence or assumption regarding shovel readiness.

(Includes – written commitment from the proponent regarding construction commencement (if approved)) The assessment teams monitor and report on the achievement of objectives (program qualification criteria) related to "shovel readiness"

#### **Assessment Criteria**


Three essential criteria will be used to identify priority projects for prioritisation through the assessment process of the planning system:

Number of Jobs Created	Timeframe for delivery	Public Benefit
<ul> <li>Total direct and induced number of jobs created.</li> <li>The period for which jobs are created (short or longer term).</li> <li>The industries in which those jobs are created and the nature of those jobs.</li> <li>Job numbers will be determined using an objective method with consistent input assumptions.</li> </ul>	<ul> <li>Shovel-readiness: can the project be determined quickly and is the project ready to commence within the next six months?</li> <li>For rezonings or site compatibility certificates: will the project provide investment certainty to enable projects to progress to assessment within 6 months?</li> <li>Investment certainty: to what extent is funding for the project secured?</li> <li>Key constraints to timeliness: Are there complex issues that are unlikely to be able to be resolved within a timeframe that would allow determination within six months.</li> </ul>	<ul> <li>Will it deliver a significant proportion of build to rent, social or affordable or key worker housing?</li> <li>Is the project directly linked to, delivers, benefits from and/or will be catalyst to deliver state or regional level infrastructure?</li> <li>Does the project provide significant public spaces, green infrastructure, environmental benefits and quality design?</li> <li>Does the project have strategic merit in that it will give effect to directions and priorities set by relevant commonwealth, state, regional and/or district plans?</li> </ul>

- Projects prioritised through this process not only deliver jobs but have strong public benefits dividends that deliver a positive legacy for communities and businesses.
- These criteria will be applied by the Department through a triage process to allocate resources to projects that best deliver short, medium and longer-term outcomes and to match the nature of the project assessment to the appropriate assessment path in the Department.



- Triaging Projects combines the Spectrum of NSW Planning:
  - Planning Proposals
  - Development Applications
  - Post Consent Matters
  - > State-led rezoning.
- The triage will be applied to the "shovel ready" lists submitted by proponents, as well as the tracking systems held by the Department for LEPs, Regional Panel DAs and Major Projects (SSDs & SSIs).
- The Department will seek proponents confirmation of construction readiness within 3 months or 6 months from determination.
- All prioritised projects will be processed within 4 weeks of being announced in a tranche.
- The program will in the first instance identify projects that:
  - > are capable of having a determination made within a specific tranche;
  - > & construction can commence within 6 months of that determination.





#### **Benefits Realisation**

- Three stages of tracking against the achievement of the objectives:
  - When selecting projects for fast-tracking: confirming that the selected projects meet the criteria and including assessment & justification in the submission to the decision maker;
  - When assessing / completing projects: monitoring & reporting on achievement of objectives in relation to assessment deadlines.
  - Post Decision: monitoring & reporting on achievement of objectives in relation to downstream development activity (construction or development approvals).



#### **Reporting & Data Management**

#### APAP provides reporting to:

- Triage Control Group.
- Planning Leadership Team.
- Precincts Coordination Steering Committee.
- Minister's Office.

#### The key features of the reports are:

- Project status
- Program schedule and performance
- Project and program risks
- Emerging issues and maters for escalation
- Project planning and resource allocation
- Benefits realisation



- Projects are tracked following accelerated decision to document outcomes in relation to the approved criteria.


