Explanation of the certification process under the State Environmental Planning Policy (Three Ports) 2013

The State Environmental Planning Policy (Three Ports) 2013 (Three Ports SEPP) was established to provide a consistent land use planning and assessment framework for the port facilities at Port Botany, Port Kembla and Port of Newcastle.

For a complying development certificate (CDC) to be issued by council for development relating to bulk liquid storage (i.e. new bulk liquid storage tanks, modification to pipelines and flow rates and change in liquid in bulk liquid storage tanks), the applicant may be required to obtain a hazard analysis, fire safety study and/or a hazard and operability study prepared by a suitably qualified person on their behalf.

As part of the certification process for complying development under the relevant clauses, the applicant submits the required hazard studies with other information requirements for the development to the certifier (Council).

Council is required to check that the certificate has been prepared by an approved person, before the CDC is issued.

For the development of bulk liquid storage tanks, clause 27 of the Three Ports SEPP requires an additional approved specialist to check the recommendations in the specified studies have been implemented and issue a certificate, prior to the issuing of a CDC.

In addition, under the Three Ports SEPP a hazard audit is required 12 months after the commencement of use of the tanks and every three years thereafter.

All suitably qualified persons must first be approved by the Secretary of the Department of Planning, Industry and Environment as having the necessary expertise to undertake the required hazard studies. The applicable clauses in the Three Ports SEPP are:

- clause 11 of Schedule 2 (complying development bulk liquid storage tanks)
- clause 12 of Schedule 2 (complying development bulk liquid storage tanks change of stored liquid)
- clause 13 of Schedule 2 (complying development bulk liquid storage tanks modification to pipelines and flow rates)
- clause 27 of Schedule 2 (additional conditions bulk liquid storage tanks).

Persons approved to prepare studies under clause 11(2) of the Three Ports SEPP cannot issue a certificate under clause 27(1)(c).

Further, both persons must come from the list of suitably qualified persons approved by the Secretary for those studies, and to ensure there is no conflict of interest, both persons must be employed by separate companies.
