BCA 2006—information seminars

This circular is to advise councils, accreditation bodies, relevant government agencies and industry groups of upcoming seminars regarding BCA 2006, including information on the new energy efficiency provisions for commercial buildings.

Introduction

The Building Code of Australia (BCA) 2006 takes effect on 1 May 2006. Knowledge of the latest changes to the BCA, especially the new provisions for energy efficiency in commercial buildings, is essential for all practitioners involved in the design, construction and certification of buildings.

A series of one-day information seminars to familiarise you with the changes before they take effect are being held around Australia starting in late-February.

The Australian Building Codes Board (ABCB), in conjunction with the Australian Institute of Building Surveyors (AIBS) will be running seminars in each capital city. In addition, a series of seminars in regional NSW will be conducted by the AIBS with input from the Department. The timetable is as follows.
