Bango Wind Farm Community Consultative Committee Details

1. Executive Summary

The Bango Wind Farm is located to the east of Lachlan Valley Way between the regional centres of Yass and Boorowa in the Southern Tablelands of NSW.

The site is located in the Hilltops and Yass Valley local government areas and forms part of a larger rural area used primarily for grazing.

Originally the project proposed the construction of up to 75 turbines, however, following submissions during the assessment process, mainly regarding biodiversity and visual concerns, was reduced and approved by the Independent Planning Commission for 71 turbines. Following an appeal to the Land and Environment Court, consent was granted for 46 turbines (to be positioned within 49 locations). The project also involves the development of associated ancillary infrastructure.

The proponent, CWP Renewables Pty Ltd, consulted with the community from the commencement of its preparation for their development application in 2013. First meeting approximately once per year, the CCC now meets on a quarterly basis, alternatively between Yass and Boorowa venues.

The Community Consultative Committee (CCC) operates in accordance with the Department of Planning & Environment's Community Consultative Committee Guidelines for State Significant Development (January 2019). The committee's membership consists of:

- Two local community representatives
- One Yass Valley Council delegate
- One Hilltops Regional Council delegate
- One stakeholder group representative (Boorowa District Landscape Guardians)
- One host landholder; and
- One Independent Chairperson.

2. CCC activities over last 12 months

Over the past 12 months, the CCC met in May 2018, September 2018, January 2019 and April 2019 and members have received presentations and updates from the proponent's representatives on:

- Environmental studies
- Management Plans
- Local contractor and employment opportunities
- Independent Planning Commission proceedings
- Land and Environment Court appeal
- Management of the surperb parrot population
- Micrositing of the turbine locations
- Tendering for construction (civil) contractor
- Consideration of turbine supplier and type of turbine proposed
- Voluntary Planning Agreements with both Councils.

The CCC is an effective communication forum between the community, the Council and the company. It fulfils its objectives under the Department's guidelines, however, attendance at the meetings has been inconsistent. The Independent Chairperson is currently advertising for additional community representatives and stakeholder group delegates to enhance representation for the broader community.

There were no joint CCC's held in the region.

3. Key issues

4. Focus for next 12 months

The focus for the next 12 months will be the proponent preparing its Management Plans and necessary approvals for the construction of the project, including the appointment of a successful civil contractor to undertake the works.

The planned activities for 2019 will be guided by the contributions of the CCC members. These activities are likely to include:

- Preparation of pre-approval requirements for construction of the project.

- Continued updates on environmental monitoring of the site.
- Implementation of the National Superb Parrot Conservation Plan.
- Implementation of the project's Community Enhancement Fund.

To the best of my knowledge, there are no outstanding or emerging issues that have not been addressed.
