1. Executive Summary

The Bringelly Brickworks CCC was established prior to PGH relinquishing its current long-standing planning approval for a new approval.

Given that the new approval has not yet been triggered (expected prior to March 2020) this report covers the period from inception in June 2016 until December 2018. The committee was formed after an expression of interest process which was advertised in local papers and in the local community shopping center hub.

The committee has met six (6) times in the period June 16 to December 18, although meetings were less frequent in 2018.

Meetings have focused on environmental impacts, including run off, dust and dust monitoring, traffic and local road conditions, road safety and driver behavior, cumulative noise, and traffic and dust cumulative impacts from an adjacent concrete batching plant proposed by Boral.

The committee has undertaken a site visit to understand the brickmaking process and to inspect the environmental procedures on site.

2. CCC activities over last 12 months

- 6 meetings between June 16 and December 18.
- Attendance at meetings has varied however each meeting has a majority of members present.
- One site visit held in July 2016 to provide an overview of plant activities and future plans.
- Additional consultation activities related to the CCC have included correspondence with CCC members outside meetings.
- Vehicle type count at brickworks gate was conducted by PGH at request of CCC.
