1. Executive Summary

The Hera Gold Mine CCC has operated within the Department of Planning Community Consultative Committee Guidelines during the year.

One community member resigned during the year after the Proponent signed an exploration agreement over part of his property and he commenced regular part-time employment with them. Advertising is currently underway to seek nominations and the department will be advised of the outcome and to request their appointment of replacements.

The CCC continued to operate with the procedure of draft minutes being circulated for comment within 7 days of the meeting and the final minutes being circulated and uploaded to the company website to permit CCC members to use them for their stakeholder consultation activities.

The company presentation at each meeting provides a comprehensive review of workplace and environment issues together with a report on production and exploration activities. This presentation is uploaded to the company website at the same time CCC minutes are uploaded.

As the drought continues the CCC were kept abreast of the contingencies being adopted to ensure an adequate water supply for the continued operations. Another result of the continuing drought was the reporting of more regular elevated dust levels, however, as a result of improved weather conditions there was a reduction in regional dust conditions

The escalation of COVID-19 to pandemic status in March required the site to implement a number of control measures. These measures ensured a safe working environment for employees and the local community.

Hera's three yearly Independent Environmental Audit report review by DPIE was completed in April. DPIE considered that the Audit Report generally satisfied Condition 9 of the consent. Hera is 80% compliant to its licence conditions with the majority of non-compliances being historical or administration related. An action plan

was submitted to DPIE to address and continually improve Hera's compliance to its licence conditions.

Environmental Impacts for Modification 6 to the Project Approval commenced during the year to permit transportation of up to 100,000 tpa from the Hera Mine to Peak Gold mines with backloads of similar volume of waste rock from the Peak Mine to the Hera Mine; use of tailings underground for backfilling operations; amendment of the current tailings WAD cyanide discharge; extension of the current approval for mining operations at the Hera Mine to December 2026; and an extension of the Project Site boundary to incorporate additional bores proposed to be installed. The EIS was on Public exhibition from 2 – 15 December 2020.

Preliminary planning commenced for the Hera camp expansion to accommodate the existing workforce and future proposed workforce, including additional construction personnel with the development of the Federation exploration and potential mining progressing. The Environmental Impact Statement (EIS) to mine Federation is in the process of being developed.

Company presentations included reports on all site injuries, environmental incidents and monitoring, complaints, production and exploration activities and were included with the adopted minutes and uploaded to the company
