1. Executive Summary

Mangoola Open Cut is an open cut coal operation in the Wybong area, 20 kilometres west of Muswellbrook and approximately 10 kilometres north of the township of Denman.

The company operates in accordance with Project Approval 06_0014 (as modified). Run of mine (ROM) coal is extracted at a rate of up to 13.5 million tonnes per annum.

Mangoola Coal is currently seeking approval for the Mangoola Coal Continued Operations (MCCO) Project to continue its current open cut mining adjacent to the north of the existing Mine.

A Community Consultative Committee (CCC) has been operating since 2006 and in 2017 an Independent Chairperson (and alternate) were appointed by the Department of Planning & Environment. The CCC operates in accordance with the Department of Planning & Environment's Community Consultative Committee Guidelines for State Significant Development (January 2019). The committee membership consists of:

- Four local community representatives (it should be noted that one community representative resigned during this reporting period)
- Two Singleton Council delegates
- Two Stakeholder Group representatives (Denman Chamber of Commerce and the Muswellbrook Business Chamber)
- Three company representatives; and
- One Independent Chairperson.

It was recommended by one of the community representatives during this reporting period that additional membership should be investigated to ensure a broad cross section of representation on the CCC. Accordingly, a recruitment campaign was conducted in accordance with the guidelines with the following nominations being approved by DPIE:

- One community representative
- o One stakeholder group representative Denman Chamber of Commerce
- One stakeholder group representative Muswellbrook Business Chamber.

The meetings are held quarterly in February, May, August & November with attendees receiving a comprehensive presentation from the proponent. Regular site inspections are undertaken. Topics of discussion during the reporting period include:

The CCC is an effective communication forum between the community, the Council and the company. It functions well and accordingly, fulfils its objectives under the Department's guidelines.

2. CCC activities over last 12 months

- The committee met in February, May (held via teleconference due to COVID-19 restrictions), August & November 2020 (in Denman Memorial Hall & via tele-conference due to COVID-19 restrictions). CCC members undertook a supervised site inspection of Main Pit Central and rehabilitation areas as part of the August CCC.
- Attendance at the meetings is high, with the occasional apology due to competing commitments of volunteers.
- Members receive an extensive presentation from the proponent regarding its environment monitoring results.
- Members received an extensive presentation from the proponent regarding the proposed Mangoola Continued Coal Operations applications, currently with the Independent Planning Commission for consideration and determination.
- Members benefit from drone footage shown during the presentation of the activities occurring on the mine site and rehabilitation results.
- There were no joint CCC's held.

- Continued updates provided on monitoring and environmental performance of the open cut mine.
- Regular site inspections, including Anvil Rock.

This is an exemplary CCC. The company are dedicated to presenting thorough information to members who are appreciative of this commitment. There are usually two site inspections undertaken every year, however, this was restricted to one in this reporting period due to COVID-19 directives.

It is worth noting that Mangoola Coal (Glencore) were winners of the Excellence in Environmental Management category of the Australian Mining Prospect Awards.

Glencore is proud of the work they are undertaking on site. The feedback from CCC members is very positive.

To the best of my knowledge, there are no outstanding or emerging issues that have not been addressed.
