### 1. Executive Summary

The Mt Arthur Coal Complex, located approximately five kilometres south west of Muswellbrook in the Upper Hunter Valley in New South Wales (NSW) includes the Mt Arthur Coal Open Cut, the Mt Arthur Coal Underground Project (no underground operations are currently taking place), Coal Handling and Preparation Plant (CHPP), rail loop and rail load out. The company operates in accordance with Project Approval PA 09 0062 (as modified).

A Community Consultative Committee (CCC) had been operating prior to 2010 and had been Chaired by a Muswellbrook Councillor. Since June 2015 an Independent Chairperson was appointed by the NSW Department of Planning, Industry and Environment (DPIE) to Chair the CCC. The CCC operates in accordance with the DPIE's Community Consultative Guidelines for State Significant Development Projects (January 2019).

The committee currently consists of

- Four local community representatives
- One elected Muswellbrook Council representative
- Four company representatives
- One Independent Chairperson, appointed by the NSW DPIE.
  - And a minute taker who records the minutes and is responsible to the Chairperson of the CCC.

#### 2. CCC activities over last 12 months

- Change in personnel
  - Dr Col Gellatly resigned as Independent Chair and Dr Wej Paradice was appointed by the NSW DPIE to the role of Independent Chair for Mt Arthur Coal (MAC), commencing in August 2019
  - · Changes in staff at Mt Arthur Coal
- Five community members and one Council representative were members of the MAC CCC during the period. One community member tendered their resignation.
- Four meetings were held during the period
  - 9 September 2019, 21 November 2019, 13 February 2020 and 7 May 2020

- Due to COVID-19 impacts, the May 2020 meeting was held as a Q&A iterative meeting
- There were no site visits held during the period, one visit was planned for February 2020, however due to COVID-19 it was postponed
- Two Joint CCC's were held with Maxwell Infrastructure
  - One face to face meeting in 11 December 2019 and the second meeting 10 June 2020, was a Q&A iterative meeting. No key issues or concerns raised.
