1. Executive Summary

The committees activities were seriously compromised by the COVID-19 lockdown The committee has been holding two meetings a year in April and October. In line with Centennial Coal's lockdown policy our April meeting was cancelled. Members were issued with quarterly updates of the mines operations and given the opportunity to address matters either through the chairman or senior colliery management Due to the death of a member, the late John Shoebridge and the resignation of the Wangi Wangi sailing club representative Sandra O'Donnell and the lack of a representative from the Central Coast council (Formally Wyong Shire) the opportunity was taken to advertise for new members to ensure a quorum. Three new members were recruited to the committee. They attended our one and only meeting for the year held on October 26 2020.

Myuna Colliery is a long-standing and discrete underground mining operation. It has a single customer Eraring Power Station and output is delivered by an overland conveyor. Examination of the colliery reports show that it has a very high compliance rate in relation to environmental benchmarks. Community complaints have been rare in recent years and are usually intermittent noise complaints.

The current downturn in the coal industry has seen a reduction in production at Myuna. Currently the colliery production is restricted to the Fassifern seam. The colliery lease also includes the Wallarah and Great Northern seams.
