### 1. Executive Summary

Meetings of the TCCCC throughout 2020 have all been impacted by the restrictions imposed by Covid 19. All of the scheduled meetings for 2020 were held with the March and June Meetings meeting held using online meeting platform. The September and December meetings were held in part in the Tahmoor Coal office but with the option to join remotely on line. While this has placed greater difficulty on both the community members and the mine staff, the meetings have generally been productive and informative and not adversely impacted by the necessary Covid safe restrictions.

# The key issue for 2020 of the Tahmoor Coal Community Consultative Committee (TCCCC) was the proposed Tahmoor South mine expansion.

- The proposed Tahmoor South expansion will result in the continuation of mining from 2022 to 2035, after completion of mining operations at Tahmoor North and the continued employment for approximately 400 people.
- Responses to submissions was finalised and Project Amended Report submitted February 2020.
- Ongoing community consultation continued despite the restrictions of Covid 19 including an 8 page newsletter letter box dropped in the Bargo area in April 2020 and online Live Q&A in April 2020.
- Following consultation an amended proposal was submitted to DPIE in August 2020 and two longwalls were removed from the proposed plan which equates to an 80% reduction in the number of properties directly mined beneath and reduced the mine plan timeframe from 13 years to 10 years. The revised proposal also completely eliminated the REA extension footprint from the initial proposal to clear 43 hectares, as the height of the existing footprint has been increased by a maximum of 10m.
- The proposal has been referred to the IPC and public hearings commenced in February 2021 (after the 2020 reporting period).

#### The remediation of Myrtle Creek and Redbank Creek where cracking has occurred.

• A Trial Plan for Pool 23 was undertaken with the injection of polyurethane and other possible techniques and the Polyurethane Resin (PUR) grout curtain wall at Pool 23



installed earlier in the year has been observed to be site most successful in returning pool holding capacity.

- Five small pools have been remediated. In **Redbank Creek**, drilling to 2m and injecting PUR in a grid pattern to create a surface seal. Results show improvements and look promising.
- Work is continuing on other pools in both Myrtle Creek and Redbank Creek.
- Ongoing long term monitoring of pool retention and creek ecology will continue in both creeks.

The TCCCC monitored progress on the proposed Wastewater Treatment Plant for the treatment of heavy metals (Ni, As, Zn, Cu, N, Al and EC) from discharge water from the mine site which has not been successful to date and has required considerable investigation and modification. A proposed Reverse Osmosis Treatment Plant was put out for tender and tender period ended in mid-April 2020. The proposal is for pilot plant to be established prior to installation of the full Wastewater Treatment Plant later in 2021.

The TCCCC monitored the mining in the Western Domain with LW W1 mining commencing on 15 November 2019 and completed on 6 November 2020. LW W2 mining commenced in December 2020. LW W3-W4 Extraction Plan document preparation and Government Agency and community consultation has commenced. Submission of LW W3-W4 Extraction Plan is anticipated in early 2021.

The TCCC monitored the ongoing research into Thirlmere Lakes by Water NSW and universities. A Science Day held early in the year presented findings of research to date, and there is still another year of study to complete. Pamphlets handed out at the event included information regarding the current findings, including the confirmation of a correlation between rainfall and lake level.

#### A number of changes to the TCCCC membership occurred during the year:

- Virginia Fairley's resignation as a Community Member of the TCCCC was received in December 2020 and Virginia was thanked for her time and valued input on the committee.
- Fiona Robinson Tahmoor Coal Representative left Tahmoor Coal in June 2020 and the committee thanked her for all her hard work and dedication to the business and TCCCC.
- Zina Ainsworth was added as a Tahmoor Coal Representative of the TCCCC in June 2020.
- Amanda Francis was added as a Tahmoor Coal Representative of the TCCCC in September 2020.
- As a result of changes to the committee the signatories to the TCCCC bank account were changed with the Independent Chair Michael Muston, Community Member Col Mitchell and Tahmoor Coal representative Zina Ainsworth now able to sign with any two needed.
