 Flood Depth and Level Plan



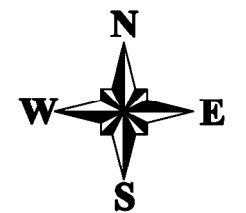
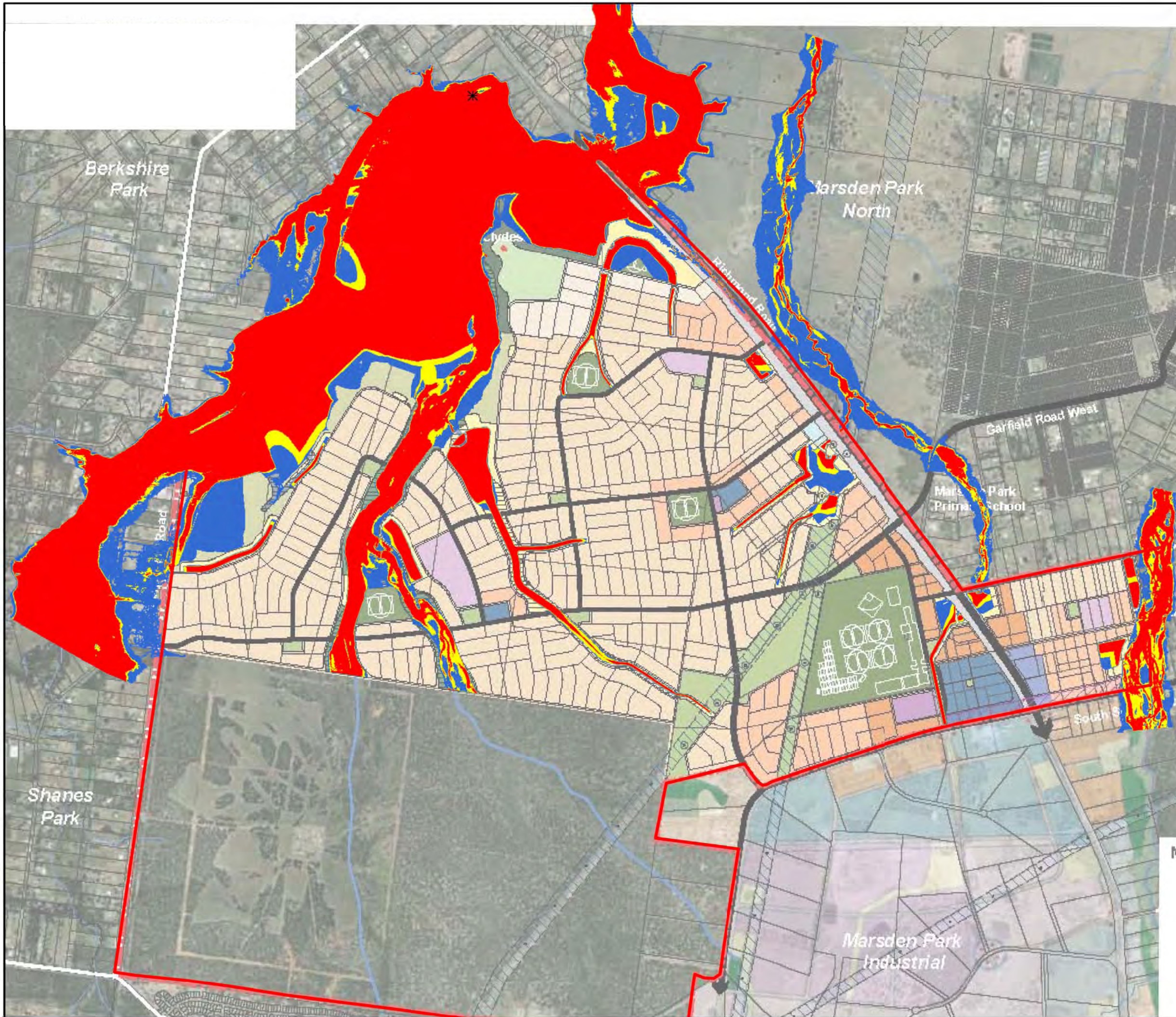

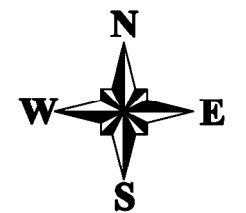

Flood Depth and Level Plan






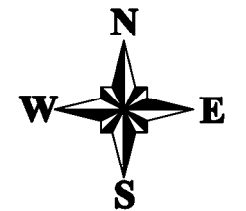
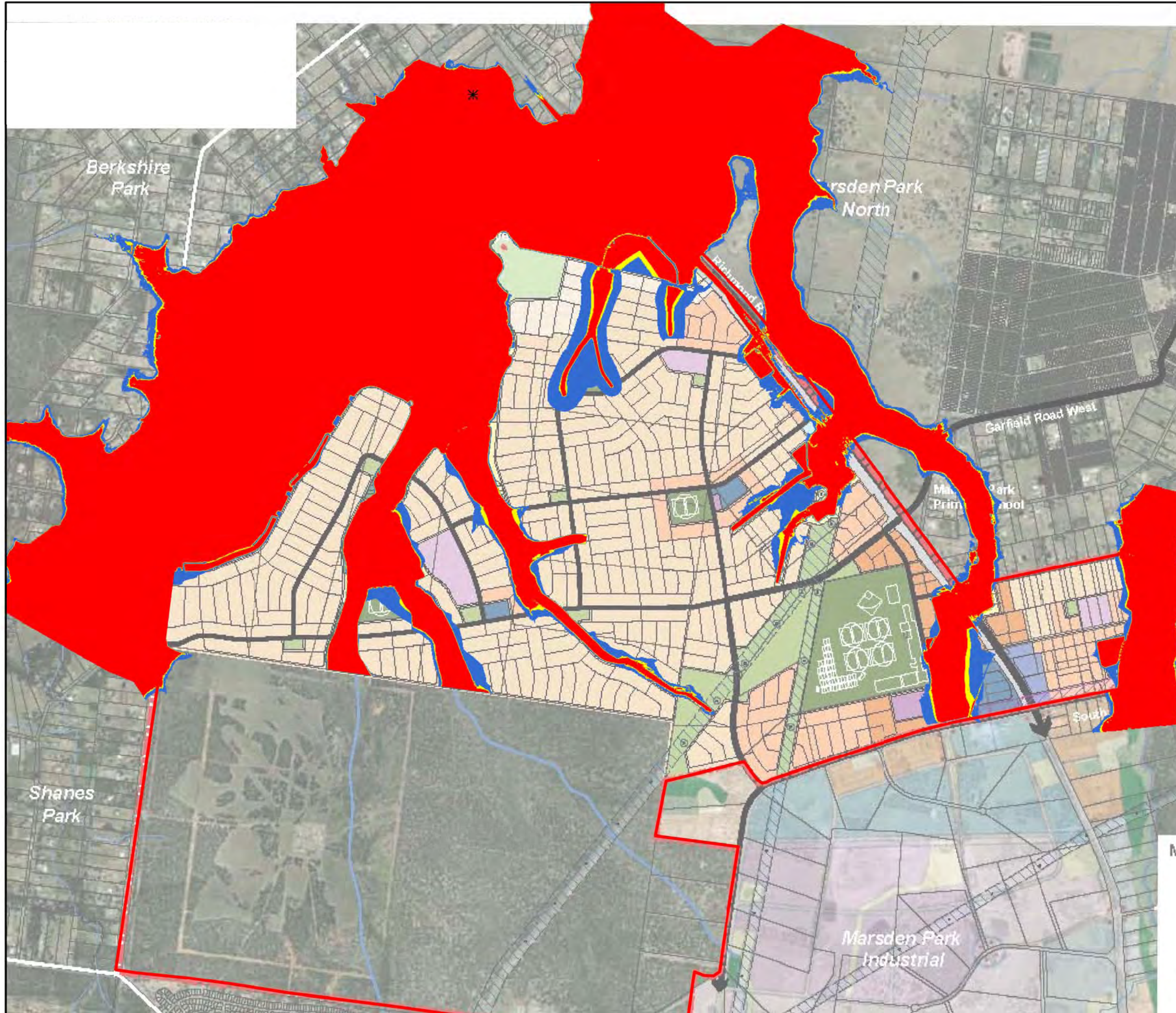

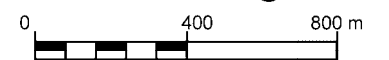
