## 1. Executive Summary

The EnergyAustralia Lithgow Regional Community Consultative Committee (CCC) was established in 2018 and combined previous committees overseeing the operational Mt Piper, the decommissioned Wallerawang Power stations as well as the Pine Dale Mine.

Mt Piper Station supplies around 14% of the NEM baseload generation capacity and is envisaged to remain operating through to 2040. Pine Dale mine is in care and maintenance mode with no active operations on site. As Wallerawang station has been disposed of and is under new ownership the CCC no longer has oversight of operations or planning for this area.

The CCC operates in accordance with the Department of Planning and Environment's 2019 Community Consultative Committee Guidelines for State Significant Projects. The Committee is currently comprised of:

- seven local community representatives
- a representative from Lithgow City Council
- three Energy Australia representatives, with attendance from other personnel as required
- one independent Chairperson.

The committee meets 3 times per year. As per the guidelines, CCC members are aware that there is a mechanism to request a meeting outside of this regular schedule, if required.

Community representatives' attendance has been variable this year due to ongoing impacts of COVID and illness amongst members. Due to technology problems and poor connectivity in the area, online meetings have not proved a satisfactory format for members. The group is very comfortable with face-to-face meetings continuing. Measures to address lower attendance are outlined in Section 3.

At each meeting the committee is briefed on several standing matters as well as projects in focus. The committee has had opportunities to be informed of, and provide feedback on, matters relating to:

- site operations
- environmental performance
- the changing nature of the energy market and the transition to renewables
- planning studies including:
  - the Mt Piper Battery
  - Lake Lyell Pumped Hydro
- site water management and dam monitoring
- community matters.

#### 2. CCC activities over last 12 months

Committee meetings were held on the following dates:

While there are quite differing views among committee members, the group continues to work constructively, and varying views have all had an opportunity to be heard. In addition to CCC meetings all members have direct channels of communication with the EnergyAustralia community relations lead.

CCC members have also been forwarded copies of relevant media releases, notifications, and newsletters as they became available.
