## 1. Executive summary / introduction

The Chain Valley and Mannering Community Consultative Committees received Departmental approval to merge into one committee, whilst under the same operator in 2016. The mines assets and operations were acquired from Great Southern Energy to Sev.en Group in December 2022 but retains the trading name as Delta Coal. The collieries provide domestic coal to the nearby Vales Point Power Station via an overhead conveyor. Site infrastructure is located within the Central Coast Council Local Government Area and underground workings are under Lake Macquarie in the Lake Macquarie Council Local Government Area. The site encompasses a footprint of approximately 27.62 hectares and is located 60 kilometres south of Newcastle, in proximity to the town of Mannering Park.

At each meeting the committee is apprised of operational activities including environmental performance and land management, monitoring, improvement programs and rehabilitation, local community news, review of Department's Guidelines and the Consolidation Project to combine existing approvals for both collieries into a single Development Consent and to extend mining operations from December 2027 to December 2029, currently pending finalisation of the Planning Secretary's assessment report before being presented for approval by the Independent Planning Commission.

The committee is comprised of:

- Seven local community representatives;
- An elected representative from Lake Macquarie City Council;
- A representative from Central Coast Council;
- Three company representatives, with attendance from other personnel as required;
- One independent Chairperson.

## 2. CCC activities over last 12 months:

- The committee met four times during 2023, in February, May, August and November.
- attendance at meetings remains consistently high, even in the absence of local government representation.

- There were no site tours undertaken for the period, although the meetings are held on site.
- The committee is an effective one by virtue of the fact that the community representatives are a dedicated, long term group of community minded people, well respected and known within their respective areas. Delta Coal representatives provide informative and productive meetings in response to the members' needs. 2023 was another year without any community complaints, indicative of effective community engagement. It fulfils its purpose under the current Departmental guidelines. All committee members have signed the revised Code of Conduct and Declarations of Interest documents and adopted a Terms of Reference as required by the Department.
