1. Executive Summary.

The Holcim Dubbo Quarry Community Consultative Committee (CCC) was established in 2020.

The quarry is located at the termination of Sheraton Rd. Operations are transitioning away from the existing pit to an identified expansion continuation area directly to the west and south of the existing extraction area.

The CCC operates in accordance with the Department of Planning and Environment's Revised 2023 Community Consultative Committee Guidelines for State Significant Projects.

The committee meets two times per year. Community representatives' attendance has been solid with a quorum for all meetings. Throughout the year the committee has had opportunities to be informed of, and provide feedback on, matters relating to:

- planning for the quarry continuation project
- site operations
- environmental performance
- sustainability initiatives
- traffic issues.

2. CCC activities.

- been asked to identify issues to be addressed within the forthcoming Independent Environmental Audit.
- been forwarded copies of relevant media releases and notifications, and updates as they became available.

3. Key issues.

Matters discussed are detailed within the various meeting minutes. The following table provides an overview of key issues of interest to the CCC:

Issue	Actions Taken	Next Steps
Trucks within school zones	Holcim has outlined actions taken to manage truck movements during times specified in the conditions of consent including driver inductions. Improvements have been evident within the past 12 months. It should be noted that Holcim's quarry is not the only operation utilizing Sheraton Rd.	Schools have direct line of communication with the quarry manager to report trucks using the roads outside of specified times or to report unsafe driving. This is a standing matter on the CCC agenda.
Alternative access routes	The group has consistently advocated for alternative routes to bypass the school zones.	This is a matter that falls outside of the project scope. It is understood that Council has long term plans to look at alternate routes for heavy vehicles.
Environmental performance	Monitoring data presented to CCC.	Ongoing updates.

4. Focus for next 12 months.

The committee will meet twice in 2025. Agenda items will be guided by the contributions and interests of CCC members. Discussion is likely to encompass:

- traffic
- ongoing environmental performance
- site operations
- CCC guidelines and ideas to extend current membership.

As per the guidelines group members can nominate agenda items for meetings and the proponent is quite responsive to these requests.
